## PAYMENT AND REFUND POLICY

Full tuition is due at the time of registration.

**If a session is cancelled by The Kate:** Full Refund.

**Withdrawals before June 5th:** Refund, less \$25.

**Withdrawals after June 5th** No refund or credit.

## FORMS & SPECIAL NEEDS

Students cannot participate without returning a fully completed and signed Registration Form (unless you registered online), and a fully completed and signed Medical Form within two weeks of the first day of the session.

It is important that we be aware of any special issues or challenges your child may face so we can create a successful and rewarding experience for your child. Please write down any and all medications, disabilities, and any physical, emotional, or behavioral challenges your child may have on the appropriate form. Feel free to schedule a time to discuss with the Camp Director by calling 860-510-0473 ext. 214. All staff and instructors follow our confidentiality policy and your privacy will be protected.

Please note that staff cannot dispense medication to your child unless a Medical Authorization Form has been received. Medications must be accompanied by written instructions for emergency procedures, and will be kept with the camp's First Aid kit.

## DROP OFF & PICK UP

Parents are responsible for their child's safe arrival at the camp and for picking them up at the end

of the session. **Parents, please be aware that you must sign your children in and out of camp each day.** This is for their safety. If a camper is picked up but not signed out we can only assume the child is missing. Please avoid unnecessary panic by signing your child in and out every day. There is no supervision provided for campers before the official start time of camp. Please do not leave your child at the camp site before the start time. Children need to be picked up on time from camp, as supervision is not available after camp ends. Only children enrolled in the camp program are allowed in the building.

## ABSENCE AND ILLNESS

Please alert the Kate if your student will be late or absent by calling 860-510-0473 ext. 214. If your child is ill, contagious and/or running a fever, please **DO NOT** bring him/her to camp.

## CODE OF CONDUCT

We value each and every individual participant and in order to create an environment where each student has the freedom to grow both as a performer and as an individual, the Kate does not tolerate the following:

- Fighting with another student, staff, volunteer, or parent
- Destruction or theft of any property or materials
- Disrespect towards oneself or others
- Use of inappropriate language and/or innuendo
- Racial or sexual harassment (including inappropriate physical contact)

Any child who misbehaves will be verbally reprimanded by Camp staff. Upon the second offense, they will be given a time out. Upon the third offense, the parent or guardian will be called and the child dismissed for the day. The Kate reserves the right to expel any child who consistently displays negative behavior. Refunds will not be issued upon expulsion.
